Private Charters

PRIVATE CHARTER EVENT (BOAT ONLY)

For group sizes 20-100 passengers. Weddings and Groom's Dinners are recommended to stay at 85 guests or less.

2-HOUR CHARTER FEE

May 21-June 17	\$1595, additional time is \$650/hr plus 21% service charge.
June 18-Sept. 10	\$1895, additional time is \$750/hr plus 21% service charge.
Sept. 11-Oct. 15	\$1595, additional time is \$650/hr plus 21% service charge.

1-HOUR PRIVATE CHARTER (BOAT ONLY)

For group sizes 20-100 passengers.

1-HOUR CHARTER FEE

\$850 plus 21% service charge.

PRIVATE DOCKSIDE VENUE (BOAT ONLY)

For groups of any size. If adding catering services, 20 passenger minimum.

PER HOUR DOCKSIDE FEE

\$350/hour plus 21% service charge.

Terms & Conditions

FEES & DEPOSIT REQUIRED

Cruises aboard the Gull Lake Cruises North Star yacht departing from homeport at Cragun's Resort on Gull Lake will be assessed a \$2.50/person boarding fee. Private parties seeking custom port arrangements will be assessed a \$5/person boarding fee and a \$200 round-trip port fee (\$300 for North lake pickups) and must have their port approved by the Gull Lake Cruises charter office. The vessel will be at the landing dock to begin boarding passengers 30 minutes prior to and 15 minutes after the charter time without extra charge unless pre-approved with manager. The navigational route of the North Star is at all times to be at the sole discretion of Gull Lake Cruises.

The chartering party, in consideration of the above performance of the North Star, agrees to pay Gull Lake Cruises the minimum charter fee for 20 adults and any additional charges up to a maximum of 116 passengers for two hours underway. In excess of the two hours, the charge is \$650 or \$750 per additional hour depending on event date plus 21% service charge or portion thereof. Gull Lake Cruises restricts the right of admission to capacity of the vessel and is not responsible for accident, loss, or damage to property.

A deposit of \$800 is required upon signing this contract to reserve the desired charter date and to bind the chartering party to their full payment. **FORFEITURE OF CHARTER DOES NOT NEGATE THE LIABILITY FOR PAYMENT OF MINIMUM CONTRACT.** Chartering Party agrees to pay collection costs if necessary, including reasonable attorney fees. Any litigation arising from or relating to vessel passage shall be conducted in the state of Minnesota, and Chartering Party accordingly consents to the jurisdiction of the courts of the State of Minnesota.

Charter fee (less \$800 deposit) **MUST BE PAID IN FULL NO LATER THAN 24 HOURS AFTER DEPARTURE** in accordance with the total number of passengers and length of charter reserved. Failure to meet this requirement will result in a \$250 service charge. Any charges for additional services incurred during cruise must be paid in full upon final invoice. Please be prepared to pay with cash or credit card. If balance is not received, a \$250 service charge will be assessed. All events will incur an 21% service charge, a fuel surcharge per hour and MN sales tax applied to total bill services.

FOOD ORDERS

Final passenger counts must be in one week prior to cruise. Any last minute add-ons will be billed to final invoice.

CANCELLATION/REFUND

Event deposit will be refunded in full if event is cancelled 90 days prior to event date. Deposit may be applied to rescheduled events if the event is rescheduled 30 days prior to original event date (contingent on space and availability).

Groups canceling within 30 days of the event **WILL BE RESPONSIBLE FOR ALL PROJECTED CRUISE CHARGES.**

In case of uncertainties due to mother nature, the ship will sit dockside until the storm passes or at the discretion of Gull Lake Cruises are deemed too dangerous to cruise. A cruise reschedule is offered for up to one year, or a full refund of initial deposit plus any other payment or fares will be issued. Food intended for cruise must be paid in full and will be delivered to any alternative location. The Chartering Party hereby releases Gull Lake Cruises from any damages resulting therefrom (ride at your own risk).

FOOD & BEVERAGE SERVICE

Gull Lake Cruises reserves all catering, refreshment and alcoholic beverage sales, and concessions, whether sold or given away. **NO OUTSIDE FOOD OR BEVERAGES ALLOWED.*** To do so may result in premature termination of your event without return of fares. Food may not be taken off the boat per MN Department of Health regulations. In the case of outside resort catering, it is understood the catering service is responsible for providing the set-up, catering and clean-up service for their chartered events. Catering service must also provide dinnerware for guests, unless pre-arranged with Gull Lake Cruises general manager.

*Exception: Special wines/champagnes may be brought on board with a \$25 cork fee per bottle. Please inform the cruise coordinator **PRIOR** to your event.

ALCOHOL

LAW PROHIBITS ALCOHOL CONSUMPTION BY PERSONS UNDER 21 YEARS OF AGE. Photo ID is required. Gull Lake Cruises reserves the right to refuse alcohol service to anyone. All alcohol must be served by Gull Lake Cruises staff, and any misconduct that compromises the safety of the passengers, crew, or yacht will result in immediate termination of cruise/event. Upon cruise/event termination, the Chartering Party is responsible for all billable event fees. **NO REFUNDS WILL BE MADE.**

BOARDING

The North Star yacht will be available for boarding up to 30 minutes prior to the scheduled event time. When the event time is over, guests must disembark the vessel within 15 minutes, or the authorized representative of the Chartering Party will be charged for additional event time. Gull Lake Cruises reserves the right to examine any carry-on items including bags/purses. All boarding guests must have a crew member present at the boarding ramp to board, otherwise it is a board at your own risk policy.

CHILDREN

Children are welcome and encouraged to join any Gull Lake Cruises event as long as they are accompanied by responsible adults. Our vessel is required by law to have life jackets on board for all children. The life jackets are extremely safe but can be uncomfortable for young passengers, so passengers are welcome to bring their own. Neither state law nor Gull Lake Cruises requires small children to wear life jackets under normal cruising conditions.

HANDICAP ACCESSIBILITY

Regretfully, the North Star is not "handicap accessible" as determined by state law, but the main deck is wheelchair accessible with a handicap accessible bathroom. Please consult a cruise representative about restrictions and how our staff can accommodate your guest's special needs.

ENTERTAINMENT & DECORATION

Gull Lake Cruises will provide background music upon request at no charge. If a DJ or live band is desired, the Chartering Party will pay a coordination fee of \$150. Band members must be included in the total capacity count of the vessel, but up to four will be admitted gratis of the charter fee. Any other form of dancing or special entertainment other than a band or DJ is not permitted without consent obtained prior to the trip from the Gull Lake Cruises charter office. Any form of decoration on the North Star vessel must also have prior consent.

DAMAGES

The Chartering Party is responsible for preserving order among its guests and preventing damage from occurring to the North Star vessel and its equipment by fault of the guests. The representative of the Chartering Party hereby agrees to be responsible for any cost or expense incurred by Gull Lake Cruises as a result of damage to the vessel or its equipment inflicted by guests.
